This has reference to your application I.D. No. **6674-11/03/2022** seeking accreditation by National Board of Accreditation to Diploma Engineering program offered by **Government Polytechnic, Bargarh, At-Tentla, Po-Kantapali, Via-Bardol, Dist- Bargarh, Pin-768038, Odisha.**

2. An Expert Team conducted onsite evaluation of the program from **03<sup>rd</sup> to 05<sup>th</sup> November, 2023**. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the programs as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for 3 years. **Government Polytechnic, Bargarh, At-Tentla, Po-Kantapali, Via-Bardol, Dist- Bargarh, Pin-768038, Odisha** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted **Government Polytechnic, Bargarh, At-Tentla, Po-Kantapali, Via-Bardol, Dist- Bargarh, Pin-768038, Odisha** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
